Accordingly, if you make a partial withdrawal request that exceeds the Partial Withdrawal Limit of 95%, we will process the withdrawal up to 95% of that holding value, leaving any remainder in your account. Should you wish to make a further withdrawal from your holding value, you may do so by making another withdrawal request after the initial withdrawal has settled.

If you withdraw the full value of your holding in a fund, your account relating to that fund will be closed and you will not be able to reapply for new units in that same fund directly. Where available, you may access the fund indirectly by investing through Vanguard Personal Investor, a master trust, wrap platform or through a nominee or custody service.
